ARTICLES OF INCORPORATION

OF

MELBOURNE REAL ESTATE INVESTMENT, INC.

<u>ARTICLE I - NAME</u>

The name of the corporation is Melbourne Real Estate Investment, Inc., at 700 Atlantis Road, #207, West Melbourne, FL 32904 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK
