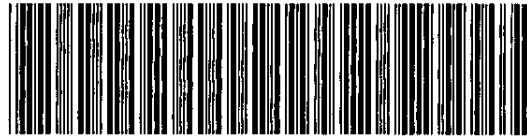



ARTICLE I. NAME

The name of this corporation is TOIE HURST CRESPI, INC.
