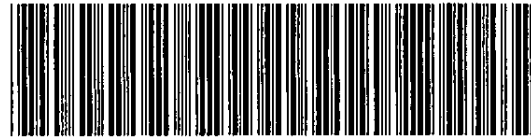

Name. The name of this Corporation is: Orange Blossom
