ARTICLE I Name and Address

The name of the Corporation shall be **FLORIDA PRINT SOLUTIONS**, **INC.**, and its address is 4215 Eleam Blvd. S.E., St. Petersburg, Florida 33705.

ARTICLE II <u>Purpose and Powers</u>
