**ARTICLES OF INCORPORATION
OF
FARBER PLASTIC SURGERY, P.A.**

The undersigned being duly licensed to practice medicine in the State of Florida, for the purpose of forming a professional corporation under the laws of the State of Florida, hereby makes and subscribes the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation is: FARBER PLASTIC SURGERY, P.A.

**ARTICLE II
PHYSICAL AND MAILING ADDRESS**

The physical and mailing address of the Corporation is 20963 Vieta Terrace, Boca Raton, Florida 33433.

**ARTICLE III
PURPOSE**

This corporation is organized for the purpose of providing duly licensed plastic surgery services, acting within the scope of practice authorized by statute and for transacting any and all business for which corporations may be formed under Chapter 821 of the Florida Statutes, as amended from time to time.

**ARTICLE IV
DURATION**

The existence of this corporation shall commence on the date of filing of these Articles of Incorporation with the Florida Department of State, and thereafter this corporation shall have perpetual existence.
