AGREEMENT AND PLAN OF MERGER

THIS AGREEMENT AND PLAN OF MERGER (the "Merger Agreement") is entered into as of November 30, 2016, by and between ADOMANI, Inc., a Florida corporation ("ADOMANI-FL"), and ADOMANI, Inc., a Delaware corporation ("ADOMANI-DE").

WITNESSETH:

WHEREAS, ADOMANI-FL is a corporation duly organized and existing under the laws of the State of Florida;

WHEREAS, ADOMANI-DE is a corporation duly organized and existing under the laws of the State of Delaware and is a wholly owned subsidiary of ADOMANI-FL;

WHEREAS, on the date of this Merger Agreement, ADOMANI-FL is authorized to issue (i) 2,000,000,000 shares of Class A Common Stock and Class B Common Stock, each par value \$0.00001 per share (collectively, the "ADOMANI-FL Common Stock"), of which 58,442,350 shares are issued and outstanding and (ii) 100,000,000 shares of Preferred Stock, par value \$0.00001, none of which are issued and outstanding;

WHEREAS, on the date of this Merger Agreement, ADOMANI-DE has authority to issue 1,000 shares of Common Stock, par value \$0.0001 per share (the "ADOMANI-DE Common Stock"), of which 1,000 shares are issued and outstanding and owned by ADOMANI-FL;

WHEREAS, the board of directors of ADOMANI-FL and the sole director of ADOMANI-DE have determined that, for the purpose of effecting the reincorporation of ADOMANI-FL in the State of Delaware, it is advisable and to the advantage of said two corporations and their respective shareholders that ADOMANI-FL merge with and into ADOMANI-DE, with ADOMANI-DE being the surviving entity, upon the terms and subject to the conditions herein provided; and

WHEREAS, the respective boards of directors of ADOMANI-FL and ADOMANI-DE and the sole stockholder of ADOMANI-DE have adopted and approved this Merger Agreement.

Now, THEREFORE, BE IT RESOLVED, that in consideration of the mutual agreements and covenants set forth herein, ADOMANI-FL and ADOMANI-DE hereby agree to merge as follows:

1. Merger. ADOMANI-FL shall be merged with and into ADOMANI-DE, and ADOMANI-DE shall survive the merger (the "Merger"), effective upon the date when this Merger Agreement is made effective in accordance with applicable law (the "Effective Date").

2. Governing Documents.

- a. The Certificate of Incorporation of ADOMANI-DE, in effect on the Effective Date, shall continue to be the Certificate of Incorporation of ADOMANI-DE as the surviving corporation without change or amendment until further amended in accordance with the provisions thereof and applicable laws.
- b. The Bylaws of ADOMANI-DE, in effect on the Effective Date, shall continue to be the Bylaws of ADOMANI-DE as the surviving corporation without change or amendment until further amended in accordance with the provisions thereof and applicable laws.

- 3. <u>Directors and Officers</u>. The directors and officers of ADOMANI-FL shall become the directors and officers of ADOMANI-DE upon the Effective Date, and the members of any committee of the board of directors of ADOMANI-FL shall become the members of such committees for ADOMANI-DE.
- 4. <u>Succession</u>. On the Effective Date, ADOMANI-DE shall succeed to ADOMANI-FL in the manner of and as more fully set forth in Section 259 of the General Corporation Law of the State of Delaware.
- 5. Further Assurances. From time to time, as and when required by ADOMANI-DE or by its successors and assigns, there shall be executed and delivered on behalf of ADOMANI-FL such deeds and other instruments, and there shall be taken or caused to be taken by it such further and other actions, as shall be appropriate or necessary in order to vest, perfect or confirm, of record or otherwise, in ADOMANI-DE, the title to and possession of all the property, interests, assets, rights, privileges, immunities, powers, franchises and authority of ADOMANI-FL, and otherwise to carry out the purposes of this Merger Agreement, and the officers and directors of ADOMANI-DE are fully authorized in the name and on behalf of ADOMANI-FL or otherwise to take any and all such action and to execute and deliver any and all such deeds and other instruments.
- 6. Stock of ADOMANI-FL. Upon the Effective Date, by virtue of the Merger and without any action on the part of the holder thereof each share of each class of ADOMANI-FL Common Stock outstanding immediately prior thereto shall be changed and converted into one fully paid and nonassessable share of ADOMANI-DE Common Stock (the "Common Stock Conversion Ratio").
- 7. Stock Certificates. On and after the Effective Date, all of the outstanding certificates that prior to that time represented shares of ADOMANI-FL capital stock shall be deemed for all purposes to evidence ownership of and to represent the shares of ADOMANI-DE capital stock into which the shares of ADOMANI-FL capital stock represented by such certificates have been converted as herein provided. The registered owner on the books and records of ADOMANI-FL or its transfer agent of any such outstanding stock certificate shall, until such certificate shall have been surrendered for transfer or otherwise accounted for to ADOMANI-DE or its transfer agent, have and be entitled to exercise any voting and other rights with respect to and to receive any dividend and other distributions upon the shares of ADOMANI-DE capital stock evidenced by such outstanding certificate as provided above.
- 8. Options and All Other Rights to Purchase Stock Upon the Effective Date, each outstanding option or other right to purchase shares of ADOMANI-FL capital stock, including those options granted under the ADOMANI, Inc. 2012 Stock Option and Stock Incentive Plan (the "Common Stock Option Plan") and any other options or rights to purchase shares of the capital stock of ADOMANI-FL shall be converted into and become an option or right to purchase the number of shares of ADOMANI-DE capital stock determined in accordance with the Common Stock Conversion Ratio upon the same terms and subject to the same conditions as set forth in the Common Stock Option Plan and any other agreements entered into by ADOMANI-FL pertaining to such options or rights. A number of shares of ADOMANI-DE capital stock shall be reserved for issuance upon the exercise of such options, warrants and rights equal to the number of shares of ADOMANI-DE capital stock issuable upon the exercise of such options, warrants and rights. As of the Effective Date, ADOMANI-DE shall assume all obligations of ADOMANI-FL under agreements pertaining to such options, warrants or rights, including the Common Stock Option Plan, and the outstanding options, warrants or rights, or portions thereof, granted pursuant thereto.
- 9. Employee Benefit Plans. As of the Effective Date, ADOMANI-DE hereby assumes all obligations of ADOMANI-FL under any and all employee benefit plans in effect as of said date or with

respect to which employee rights or accrued benefits are outstanding as of said date, including the ADOMANI, Inc. 2012 Stock Option and Incentive Plan. As of the Effective Date, ADOMANI-DE shall assume all obligations of ADOMANI-FL under agreements pertaining to such plans and the outstanding rights granted pursuant thereto.

- 10. Outstanding Common Stock of ADOMANI-DE. Upon the Effective Date, the one thousand (1,000) shares of ADOMANI-DE Common Stock currently issued and outstanding in the name of ADOMANI-FL shall be canceled and retired and resume the status of authorized and unissued shares of ADOMANI-DE Common Stock, and no shares of ADOMANI-DE Common Stock or other securities of ADOMANI-DE shall be issued in respect thereof.
- 11. <u>Covenants of ADOMANI-DE</u>. ADOMANI-DE covenants and agrees that it will, on or before the Effective Date:
- a. Qualify to do business as a foreign corporation in the State of Florida and in all other states in which ADOMANI-FL is so qualified and in which the failure to so qualify would have a material adverse impact on the business or financial condition of ADOMANI-DE. In connection therewith, ADOMANI-DE shall irrevocably appoint an agent for service of process in the State of Florida and under applicable provisions of state law in other states in which qualification is required.
- b. File any and all documents with the State of Florida necessary to the assumption by ADOMANI-DE of all of the franchise tax liabilities of ADOMANI-FL.
 - c. File the Articles of Merger as required by Florida Statute §607.1107(1)(c).
- 12. Assignment and Assumption of Certain Agreements. On the Effective Date, ADOMANI-FL assigns to ADOMANI-DE, and ADOMANI-DE assumes, all of ADOMANI-FL's right, title and interest under the agreements listed on **EXHIBIT A** attached hereto, and ADOMANI-DE shall perform each such agreement in the same manner and to the same extent that ADOMANI-FL would be required to perform if the Merger had not taken place.
- 13. <u>Amendment</u>. At any time before or after approval and adoption by the Board of Directors of ADOMANI-FL, this Merger Agreement may be amended in any manner as may be determined in the judgment of the sole director of ADOMANI-DE and the Board of Directors of ADOMANI-FL to be necessary, desirable or expedient in order to clarify the intention of the parties hereto or to effect or facilitate the purposes and intent of this Merger Agreement; provided, however, that any amendment made subsequent to the approval of this Merger Agreement by the shareholders ADOMANI-FL and ADOMANI-DE shall comply with the provisions of Section 607.1103(8) of the Florida Statues.
- 14. <u>Abandonment</u>. At any time before the Effective Date, this Merger Agreement may be terminated and the Merger may be abandoned by the Board of Directors of ADOMANI-FL or the sole director of ADOMANI-DE or both, notwithstanding approval of this Merger Agreement by the sole stockholder of ADOMANI-DE.
- 15. <u>Counterparts</u>. In order to facilitate the filing and recording of this Merger Agreement, the same may be executed in any number of counterparts, each of which shall be deemed to be an original.
