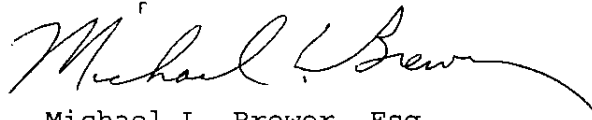

ARTICLES OF INCORPORATION  
OF

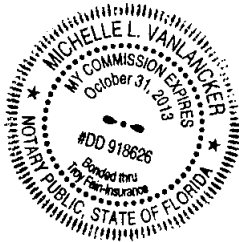

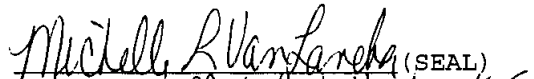
