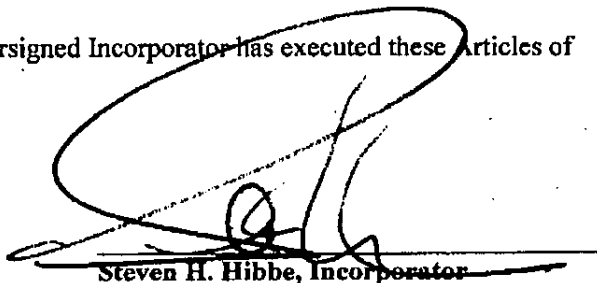
**ARTICLE IX. BYLAWS**

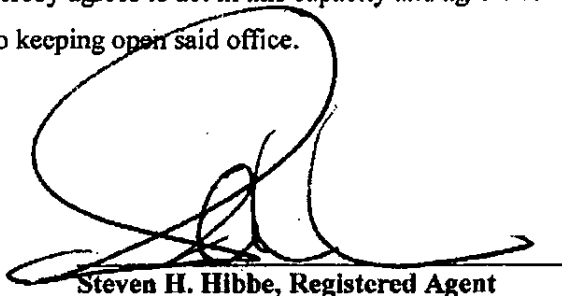
