The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is CITRUS HARVESTING, INC., whose mailing address is: P.O. Box 2119, Wauchula, Florida 33873, and whose physical address is: 2695 East Main Street, Wauchula, Florida 33873.

ARTICLE II - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK




