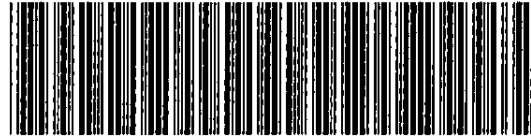



ARTICLE I. NAME

The name of this corporation is AQUA TROPICS POOL SERVICE, INC.



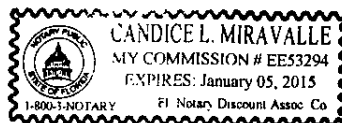
