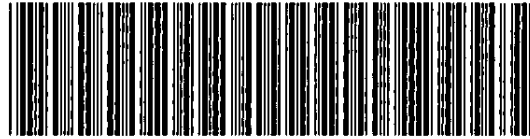

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**I**

The name of the corporation shall be *GREEN GLOBAL TECHNOLOGIES, INC.*. The principal place of business shall be 3601 Vineland Road, Suite 7, Orlando, Florida 32811.

**II**

The duration of this corporation is perpetual unless dissolved according to law.

**III**

The purposes for which this corporation is organized are:

1. To sell, service, and market a commercial surfacing product.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.






