OF

ADOPT THE FOLLOWING ARTICLES OF INCORPORATION, IN COMPLIANCE WITH F.S.  
607 and 621 FOR PROFIT.

ARTICLE I. NAME.

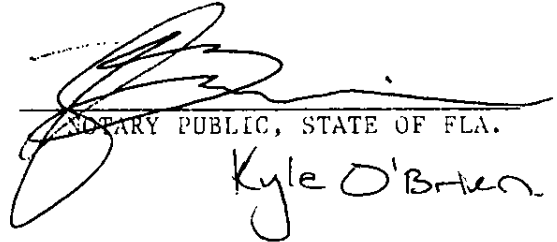

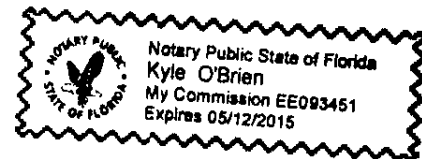
