

This Office, Secretary of State entered and filed it as **Document Number CC6857908084**. Said Document, reflected at the bottom part of the page my name, CELIA RAMIREZ Vice President 02/25/2015 as an LEGAL, Authorized and Authentic document with the electronic signature system..

2- On or around May 01, 2015, a copy of **Document Number CC6857908084**, was give to me from the Accounting Office, Secretary, _____ . THERE, I claim who had authorized to use a document with my electronic signature with the main purpose to delete my person as an incorporated Agent-Director (VP) from the record, having I none knowledge or any notice of any meeting by the member of the Corporation to proceed with such acts against me; nor, existed any cause or incident against the safeguard of the Cooperation made by myself to accept such fraudulent document. (Please, be respectfully advised the date filed said Document and the Date of Notification).

3. On or around, May 09, 2015, my self RAMIREZ, CELIA, with the help of a family's friend and I acting as Vice President for the above named Corporation requested an "SPECIAL MEETING" serving a Notary Certificate Copy to President CARDOZO, CEMETRIO, on Sunday, May 10, 2015 while I was in the Hospital. Special Meeting was set on Wednesday, May 13, 2015 at the same principal address of the CORPORATION at 2p.m. And I failed to be present because my sickness, but, my friend Alessandro Rizzo took a partial meeting with the President CARDOZO, CEMETRIO and his named Attorney, Mr. Richard E.
