ARTICLES OF INCORPORATION

OF

CAPSTONE SOLUTIONS, INC.

WHEREAS, having observed the alarming lack of an accessible, individual, specific, customized, comprehensive, and efficient advising and career planning service to college bound high school graduates and vocational trainees;

WHEREAS, realizing parents and guardians of college bound high school graduates or vocational trainees are often unduly expected to provide advising and career planning services without experience, proper training, or qualification;

WHEREAS, recognizing the need for a focused advising and career planning service with a customized individual follow up advising program;

NOW THEREFORE, in view of the foregoing and for reasons expressed below and through subsequent bylaws and actions of the Corporation, I the undersigned, being a natural person, do hereby form a Corporation as expressly stated by these Articles of Incorporation.

THESE ARTICLES OF INCORPORATION are hereby produced and acknowledged by the undersigned, to be filed with the Secretary of State of the State of Florida, in accordance with the laws of the State of Florida, for the purpose of forming a Corporation to conduct business in vocational and academic advising, career planning, and continuing advising and academic and career planning support to its clients.

ARTICLE I

SHORT TITLE

These Articles may be cited as the Articles of Incorporation of Capstone Solutions,

ARTICLE II

INCORPORATOR, NAME, BUSINESS ADDRESS, DATE OF INCORPORATION, AND DOMICILE.

- 1. The sole incorporator of Capstone Solutions, Inc. is Mr. Reuben Mekonnen of 1314 Riverside Drive, Tarpon springs, Florida 34689.
- 2. The name of the Corporation shall be Capstone Solutions, Inc. herein below referred to as the Corporation or by its name Capstone Solutions, Inc.
- 3. The principal business address of Capstone Solutions, Inc. shall be 1314 Riverside Drive, Tarpon springs, Florida 34689. The Corporation may also have branch offices and facilities necessary to conduct its business in a manner and at a location of its preference. The mailing address of the Corporation shall be P. O. Box 2504, Tarpon Springs, FL 34688.
- 4. The effective date of the incorporation and registration of Capstone Solutions, Inc. shall coincide with the date of the registration and certification of Capstone Solutions, Inc. determined by the appropriate and duly authorized agency and/or person of the state of Florida and the effective date of incorporation and registration shall, therefore, be the same date as the date of the official registration and certification of Capstone Solutions, Inc.. The certificate or letter of registration or certification shall be attached to these Articles of Incorporation.
- 5. The domicile of Capstone Solutions, Inc. shall be the State of Florida.

ARTICLE III

NATURE AND SCOPE OF THE PURPOSE AND BUSINESS OF

CAPSTONE SOLUTIONS, INC.

- 1. The general nature of the business to be conducted by Capstone Solutions, Inc. shall be:
 - (a) Providing advising and career planning services to college bound post high school students, adults, and vocational trainees;
 - (b) Offering customized continuing individual follow up support in college or vocational training establishments to post high school students or trainees who have signed up with Capstone Solutions, Inc. as clients;

- (c) Addressing issues relating to the role of parents, guardians, and financial support providers in the academic activities and career planning goals and objectives of post high school students and vocational trainees;
- (d) Working with high schools, colleges, and other educational or training institutions to help facilitate the preparation of college bound students and post high school trainees for a successful post high school academic or training experience.
- 2. Capstone Solutions, Inc. shall, as principal, agent, or otherwise, in the interest of its purpose now or hereafter stated, and for the general and specific benefit of its clients, and the furtherance of its purpose, as well as its now and hereafter stated, intended, or anticipated business objectives:
 - (a) Engage in relevant and beneficial commercial activities of every kind and class now or hereafter sanction by law, and conduct transactions now or hereafter sanctioned by law to buy, sell, hold, own, improve, operate, lease, convey, exchange, mortgage, pledge, transfer or otherwise acquire, use, and dispose off rights, privileges, obligations, any and all real properties and the rights and liabilities pertaining thereto, factories, shops, sales or showroom, apparatus, materials, supplies, wheresoever situated, and to exercise such rights and privileges as may be requisite to carry out any or all of the foregoing purposes, and To construct, equip, lease, rent, hire and manage buildings and structures of every kind and description;
 - (b) Buy, sell, deal in and supply goods, wares, merchandise and services of every kind and class, and description to the extent now or hereafter permitted by law, from any and all developers, manufacturers, producers, innovators, creative originators, distributors, sellers, fulfillers, promoters, organizers, coordinators, and service providers of every kind and class, and purchase or acquire by other legal means for owning and/or selling any other business or businesses, or their assets in full or in part, or any interest therein, and pay for the same in cash or in shares or debentures of Capstone Solutions, Inc., in one or in combination of such modes of payment, or any other means or mode of consideration now or hereafter sanctioned by law;

- (c) Raise funds by borrowing or by issuing bonds, debentures, bills of exchange, promissory notes, or other obligations or securities of the Corporation, or by mortgage or in such manner as the undersigned may deem proper;
- (d) Enter into working arrangements of any and all kinds, whether by contract, or otherwise, which such other natural or legal person[s], company[ies], or corporation[s] as the undersigned may deem convenient or beneficial to Capstone Solutions, Inc., and conclude partnership or concessions, or cooperate with any natural or legal person[s] or company[ies] conducting or about to pursue, or any lawful business transaction deemed directly or indirectly profitable to Capstone Solutions, Inc., and carry out any, all, and everything else which in the opinion of the undersigned is deemed necessary, convenient or beneficial to Capstone Solutions, Inc.
- 3. The purposes, transactions, and activities outlined herein, being so specified as the express intention of Capstone Solutions, Inc., shall be in no wise limited or restricted by the reference to or inference from the term[s] of any other clause[s] of these Articles of Incorporation, and shall be construed as independent objects, and as in furtherance of, and not in limitation to, the general powers conferred by the laws of the State of Florida upon Corporations.

ARTICLE IV

OBJECTIVES OF CAPTSTONE SOLUTIONS, INC.

- 1. The objectives of Capstone Solutions, Inc. shall be:
 - (a) Helping students prepare for post high school education or training before they enroll in a college or post high school academic or training program;
 - (b) Providing academic advising and career planning help with customized assistance to struggling students who are already in post high school academic institution, or training program without proper preparation prior to enrollment;
 - (c) Helping parents, guardians, or other supporters understand their roles and responsibilities in assisting students prepare for post high school education or training, or succeed in a post high school college or training program;
 - (d) Equipping and encouraging students to take active responsibility for their own academic and career pursuits;

- (e) Providing guidance to students, trainees, and their supporters in discovering, determining, and identifying academic acumen and career potentials through professional assessment instruments;
- (f) Assisting in tailoring an appropriate academic program relevant to and compatible with the chosen career pursuit;
- (g) Offering a continuing academic advising support in order to ensure effective and timely academic success by facilitating the orderly progression of course selection, fulfillment of specific academic requirements to the chosen field of study, and the appropriateness and compatibility of electives;
- (h) Providing a comprehensive and customized academic advising and career planning assistance to students and trainees in order to ensure academic success, timely graduation, appropriate and relevant education or training, and to safeguard against the negative outcomes of guesswork and confusion.
- 2. Capstone Solutions, Inc. offers its services through fee-based periodic workshops and seminars, as well as fee-based individually customized follow-up advising and continuing support while the student or trainee remains in college or vocational training institution.

ARTICLE V

FORMATION AND CAPITALIZATION

- 1. Capstone Solutions, Inc. is hereby incorporated as Capstone Solutions, Inc. by Reuben Mekonnen as the sole incorporator to exist and conduct business in perpetuity in the furtherance of the purposes, transactions, and activities of the Corporation stated in these Articles of Incorporation, and now and hereafter legally stated otherwise, until or unless it is terminated by due and proper legal procedure upon the maturation of terminative condition[s] or the incorporator intends and said terminative intention[s] are duly expressed in writing and approved by the incorporator.
- 2. Capstone Solutions, Inc. shall secure its initial working capital by issuing common stocks, and/or by borrowing or receiving additional funds from its sole incorporator or other sources to conduct its business and shall, without prejudice to the continuance of its operations, pay the sum

borrowed in accordance with the provisions of these Articles of Incorporation immediately upon the maturation of favorable financial conditions.

- 3. The initial working capital of Capstone Solutions, Inc. shall be not less than five hundred dollars (\$500.00). The corporation shall secure the same through the sale of common stocks and other legally sanctioned means.
- 4. Capstone Solutions, Inc. shall hereby authorize a total number of Five Hundred (500) shares of Common Stock with a par value of One Dollar (\$1.00) per share as the initial capital stock of the corporation. All shares of Common Stock shall be non-assessable, issued at and for such consideration, whether the same is cash, services rendered or otherwise, and upon such terms and conditions as may be fixed by the Board of Directors of the Corporation. The Board of Directors may issue additional shares at its discretion.
- 5. Mr. Reuben Mekonnen as the sole incorporator shall be the majority holder of the common stocks issued by Capstone Solutions, Inc. and shall acquire eighty percent (80%) of the shares of the common stocks issued by Capstone Solutions, Inc. The remaining twenty percent (20%) of the common stocks of Capstone Solutions, Inc. shall be acquired by Mr. Solomon Mekonnen.
- 6. Capstone Solutions, Inc. may declare and pay dividends to the holders of its common stocks out of its earnings after making sufficient provisions for working capital and for a healthy continuation of its stated business and earmarking necessary funds for expansion and growth.
- 7. The stockholders of the common stock of the Corporation shall have one vote for each share they own.

ARTICLE VI

BOARD OF DIRECTORS, PRINCIPAL OFFICERS, AND REGISTERED AGENT

1. The affairs of the Corporation shall be conducted by a Board of Directors of not less than one (1) or more than three (3) Directors, as may be determined from time to time by the holders of the Common Stock of the Corporation. It is not required that a director must be a subscriber or stockholder of the Corporation. The initial directors are Reuben Mekonnen of 1314 Riverside Drive, Tarpon Springs, Florida 34689; Solomon Mekonnen of 2514 Aloha Place, Holiday, Florida 34691; Teddy Mekonnen of P. O. Box, 2504 Tarpon Springs, Florida 34691.

- 2. Mr. Reuben Mekonnen of 1314 Riverside Drive, Tarpon Springs, Florida 34689 shall be the sole incorporator and the President of Capstone Solutions, Inc.
- Mr. Solomon Mekonnen of 2514 Aloha Place, Holiday, Florida 34691 shall be the Secretary Treasurer of Capstone Solutions, Inc.

Mrs. Teddy Mekonnen of P. O. Box 2504, Tarpon Springs, Florida 34688 shall be the Managing Director of Capstone Solutions, Inc.

3. The initial Registered Agent shall be Mr. Reuben Mekonnen of 1314 Riverside Drive, Tarpon Springs, Florida 34689.

ARTICLE VII

DECISIONS AND ACTIONS

- 1. Without prejudice to any and all established internal administration and management procedures or operations of Capstone Solutions, Inc., the president shall be responsible for all the decisions and actions Capstone Solutions, Inc. may make and execute at all times, unless the president delegates such prerogatives to other officer[s] of the Corporation, or third party designated or contracted to provide services or act on behalf of Capstone Solutions, Inc.
- 2. The president of Capstone Solutions, Inc. shall, in consultation with the Board of Directors, be responsible for conducting all of the businesses, transactions and activities thereof. The president of Capstone Solutions, Inc. shall hire the necessary administrative and management officers thereof.
- 3. All documents and records including minutes, copies of all financial records, and copies of all transactions and contracts shall be maintained and preserved by the office of the president.

ARTICLE VIII

INDEMNIFICATION

Capstone Solutions, Inc. shall indemnify every person who is serving or has served as an officer, director, employee or agent of the Corporation, or, at its request, of any other corporation of which it is a stockholder or creditor and from which such person is not entitled to be

indemnified, in the manner and to the full extent permitted by the Florida Statutes, subject to the limitations on and conditions of such indemnification set forth therein, which indemnification shall not affect any other rights to which such persons may be entitled.

ARTICLE IX

AMENDMENTS AND ENFORCEMENT

- 1. The Corporation shall upon the decision made by the president, the Board of Directors, and other authorized officers, if any, amend, alter, change, or repeal any provision[s] of these Articles of Incorporation.
- 2. All rights and privileges conferred upon the officers of the Corporation in these Articles of Incorporation are granted subject to the provisions of these Articles of Incorporation and subsequent stipulations in all of the instruments thereof.
- 3. These Articles of Incorporation shall enter into force as of the effective date of the Incorporation of Capstone Solutions, Inc. as provided in Article II 3 hereof.
