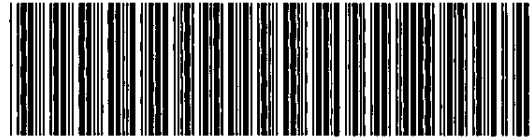

The name of this corporation is BIOCLEAN OF CENTRAL FLORIDA, INC.

ARTICLE II. DURATION




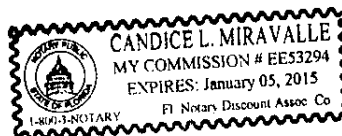
