ARTICLES OF INCORPORATION OF TT OF SMYRNA BEACH, INC. (a Florida corporation)

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of TT OF SMYRNA BEACH, INC., a corporation being organized under the laws of the State of Florida.

ARTICLE I. Name

The name of the Corporation is "TT OF SMYRNA BEACH, INC." (hereinafter called the "Corporation").

ARTICLE II. Purpose
