# ARTICLES OF INCORPORATION OF PIKE & ESTEINER CORPORATION

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

# **ARTICLE I**

# NAME

The name of this corporation is Pike & Esteiner Corporation.

# ARTICLE II

# PRINCIPAL OFFICE

#### TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such state of law and such shall commence at the time of the filing of these Articles of Incorporation with the Secretary of State of Florida.

# PERMITTED ACTIVITY
