#### Bonnie Gail Sanders Curc For Lupus Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 40,000 of which 20,000 shares of par value \$1.00 per share shall be designated as Common Stock and 20,000 shares of par value \$1.00 shall be designated as Preferred Stock.
