ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

- Section 1.1 <u>Name</u>. The name of the corporation is Pure Living Acupuncture and Natural Health, Incorporated.
