**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The following amendments to the Articles of Incorporation of CABAMO CORP. were unanimously adopted by the Board of Directors of the corporation, and by unanimous approval of all of the Shareholders of the corporation at a Special meeting held on September 12, 2012, in the manner prescribed by Florida Statutes:

ARTICLE VIII- INITIAL OFFICERS

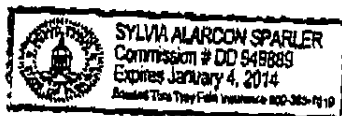
