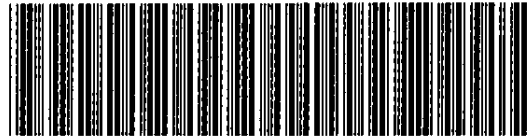

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE 8-28-12

The name of the Corporation ("Corporation") is Mark's Finance, Inc.

ARTICLE II

The existence of the Corporation shall begin on August 28, 2012.

ARTICLE III

The street address of the principal office of the Corporation is 7125 South Pine Avenue, Ocala, Florida 34480.
