3. The Articles of Incorporation are hereby amended by deleting Article III in its entirety and substituting therefor the following:

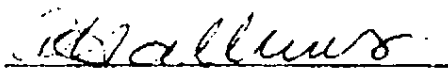
ARTICLE III - SHARES
