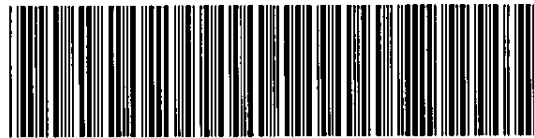

ARTICLE I


AMENDMENT:
