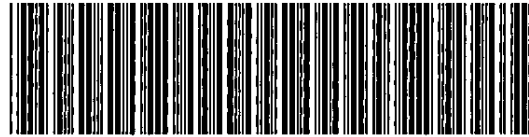



ARTICLES OF INCORPORATION

LITTLEBUS SERVICES, INC.

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is LittleGus Services, Inc. and its principal place of business shall be located at 500 North Ocean Street, Jacksonville, FL 32202.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of common stock at One Dollar (\$ 1.00) par value, which shall be designated as "Common Shares."

The whole or any part of the authorized Common Shares may be issued for such consideration having a value not less than the par value of the shares issued therefore as is determined from time to time by the Board of Directors.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - POWERS

The general powers of this corporation shall be all corporate powers as specifically set forth in §607.0302, Florida Statutes; to operate, conduct, carry on and engage in any business or businesses not prohibited by law.

The foregoing clauses shall be construed both as objects and powers and it is expressly provided that the foregoing enumeration of specific powers and objects shall not be held to restrict or limit in any manner the general powers or objects of this corporation. In general, to carry on any other business in connection with or related or incidental to the foregoing permitted by law; to have and exercise all the powers conferred by the present or future laws of the State of Florida upon corporations formed for any or all of the purposes aforesaid.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is at 500 North Ocean Street, Jacksonville, FL 32202, and the name of the initial registered agent of this corporation at that address is Roy E. Dezern, Esquire.

ARTICLE VIII - DIRECTORS

Initially, this corporation shall have Two (2) Directors who shall serve until his successor shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than two (2) directors constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the Bylaws. The names and addresses of the initial directors are as follows:

ARTICLE XII - INDEMNIFICATION






