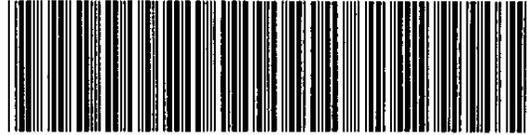

OF THE BOARD OF DIRECTORS OF AVIFLEX AVIATION CORP.**

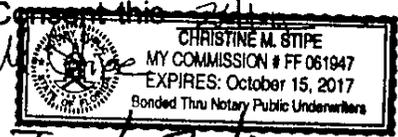
