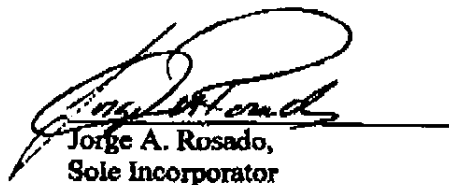
ARTICLE IX. BYLAWS
