Jacobs, PL (Document # L12000121927) on 9/24/2012 when the entity that should have been formed should have been Eric A. Jacobs, PA.. I immediately then contacted the department and advised them of what had transpired. The person to whom I spoke advised me that her supervisor was able to intercept and reject the filing and that I would be receiving a confirmation. Unfortunately, the agent rejected the wrong entity. That is, instead of rejecting the PL that was not yet up, they rejected the PA which was only created after they in fact confirmed that I could do so. I specifically asked if I would pay both fees and was told no and was assured that it had been done. I was then advised by my bank today what transpired and upon calling the department, I learned of what I've described herein. Please restore the filing(s) / reject the filings such that the PL is rejected and the PA is accepted. Any efforts at expediting are appreciated, I secured a Tax ID # and did other things in reliance upon what I was told by your agent only to find that it had not happened. I urgently need to get this resolved and my operation is basically on hold pending its resolution. I specifically do not want to utilize (and have not) a PL because it would be a single member PL and could be treated as a disregarded entity. Your assistance is appreciated.
