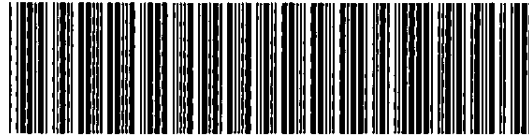

The undersigned incorporator, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following articles of incorporation.

ARTICLE I. CORPORATE NAME

The name of this corporation is STITES (2), INC.
