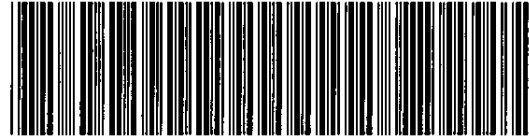

## ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

### ARTICLE I - NAME

The name of this corporation is Shaunda Brown Attorney and Counselor At Law, P.A..

### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

### ARTICLE III- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a Professional Legal Services provider. It is incorporated solely and specifically for the purpose of rendering professional legal services; therefore the purpose of this professional association is to conduct business as attorneys.
