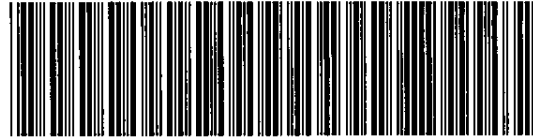

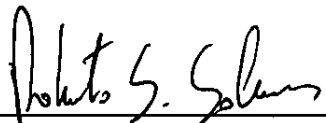
**ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE**

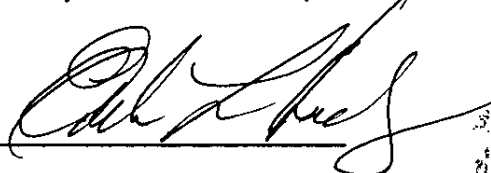

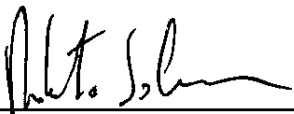
