The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is R' Mission, Inc., and its principal office and mailing address is 1227 N. Franklin Street, Tampa, Florida 33602.

**ARTICLE II**

**Commencement and Term of Corporate Existence**

The corporation shall come into existence on the date of filing with the Florida Secretary of State. This Corporation shall have perpetual existence.
