ARTICLES OF INCORPORATION

OF

A & C CLEANING GROUP, INC.

ARTICLE I - NAME

The name of the corporation is A & C Cleaning Group, Inc., at 70 Wintergreen Avenue, Malabar, FL 32950 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK
