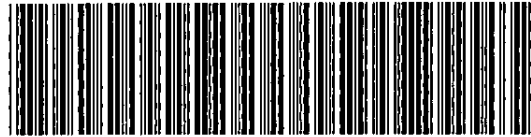

**ARTICLE I-NAME**

**ARTICLE II-ADDRESS**

### **ARTICLE XIII-BUSINESS TRANSACTIONS**

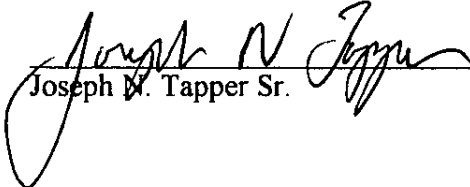

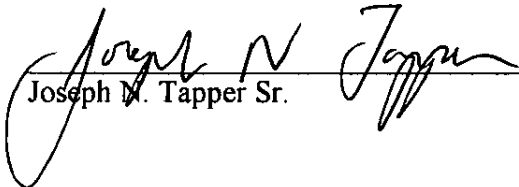
