**ARTICLES OF INCORPORATION
OF
IP ENFORCEMENT LAW GROUP, P.A.**

The undersigned, acting as incorporator of the captioned professional corporation under the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
Corporate Name and Principal Office**

The name of this professional corporation is IP Enforcement Law Group, P.A., and its principal office and mailing address is 1227 N. Franklin Street, Tampa, Florida 33602.

**ARTICLE II
Commencement of Corporate Existence**

The professional corporation shall come into existence on the date of filing with the Florida Secretary of State.

**ARTICLE III
General Nature of Business**

The professional corporation has been formed for the purpose of engaging in the practice of law through its officers, employees and agents who are licensed to practice law in the State of Florida, and any business incidental thereto which is lawful under the Florida Professional Service Corporation Act.

**ARTICLE IV
Capital Stock**

The aggregate number of shares of stock authorized to be issued by this professional corporation shall be 1000 shares of common stock, each with a par value of \$.001. Each share of issued and outstanding common stock shall entitle the holder thereof to fully participate in all shareholder meetings, to cast one vote on each matter with respect to which shareholders have the right to vote, and to share ratably in all dividends and other distributions declared and paid with respect to the common stock, as well as in the net assets of the professional corporation upon liquidation or dissolution.


ARTICLE VII
