**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Summit Vista Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

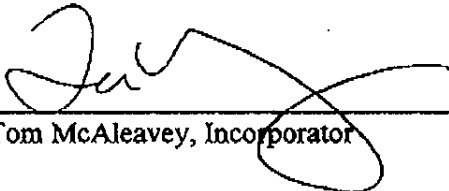
