**ARTICLE I. NAME OF CORPORATION**

AUSTIN RESIDENTIAL, INC. (the "Corporation")

**ARTICLE II. LIQUIDATION**

The Corporation entered into a Plan of Liquidation on December 10, 2024, which provided, among other things, following the liquidation of its assets, the proper parties would dissolve the Corporation.

**ARTICLE III. AUTHORIZATION OF ARTICLES OF DISSOLUTION**


A. Consent. The Corporation, by written consent of its shareholder, has elected to dissolve. The number of votes cast for dissolution was sufficient for approval.
