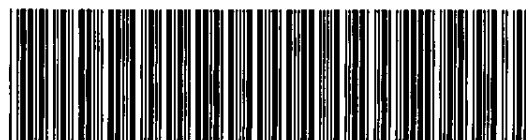

ARTICLES OF INCORPORATION
OF
KEVIN W. KULOW, M.D., P.A.

ARTICLE I - NAME

The name of this corporation is Kevin W. Kulow, M.D., P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing of medical services.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

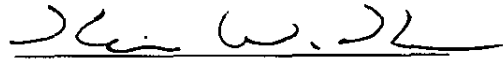

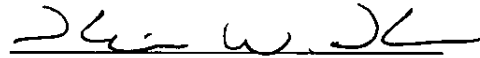

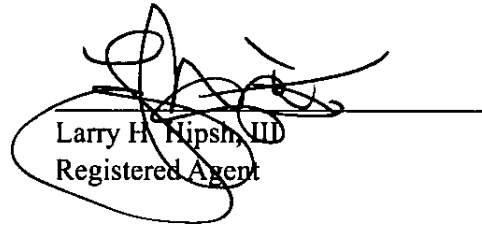
