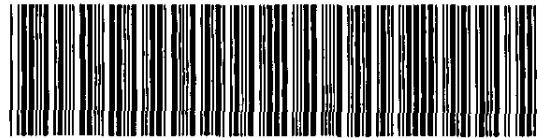

Pursuant to §607.1403 of the Florida Business Corporation Act, **HIERROMAT TRADE GROUP, INC.**, a Florida corporation (the "Corporation"), submits and files these Articles of Dissolution with the Florida Department of State and provides the following information:

1. ARTICLE FIRST: The name of the Corporation is **HIERROMAT TRADE GROUP, INC.**
2. ARTICLE SECOND: The complete dissolution and liquidation of the Corporation was duly adopted and approved by the unanimous written consent of the members of the Board of Directors of the Corporation and by the unanimous written consent of the shareholders of the Corporation pursuant to §607.1402, §607.1403, §607.0821, and §607.0704 of the Florida Business Corporation Act on May 1, 2014. The number of shareholder votes cast for the dissolution of the Corporation was sufficient for approval thereof.
3. ARTICLE THIRD: The effective date of the dissolution of the Corporation shall be the date of filing of these Articles of Dissolution with the Department of State of Florida.

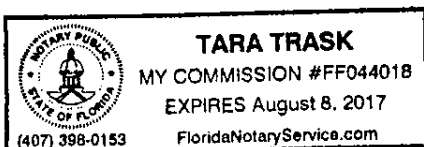
