**ARTICLE I. NAME**

The name of the corporation is **CANDACE HOUSING CORP.**

**ARTICLE II. DURATION**

**ARTICLE VIII. INITIAL BOARD OF DIRECTORS**

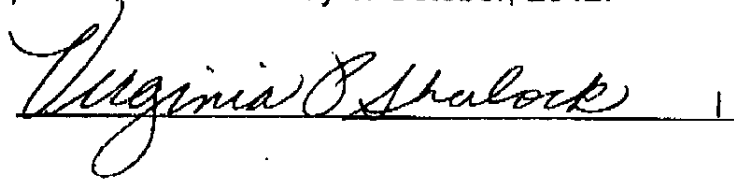

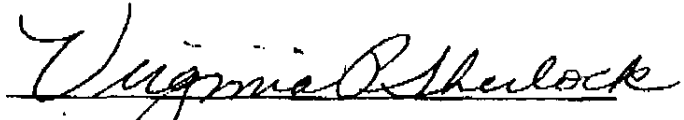
