



ARTICLE I

The name of this corporation is: Wisdom Futures, Inc.

ARTICLE II

The principal place of business and mailing address of the corporation in the State of Florida is: 12 Palm Point, Jupiter, Florida, 33458.


The power of the sole incorporator as such shall terminate upon the filing of the Articles of Incorporation.
