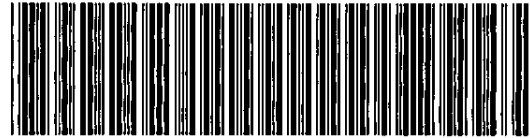

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I: Name**

The name of this corporation is **MAHATHI REDDY, M.D., P.A.**

**ARTICLE II: Principal Place of Business**

The corporation has a principal place of business of 4113 Little Road, Suite 101, New Port Richey, FL 34653 and mailing address of 4113 Little Road, Suite 101, New Port Richey, FL 34653.

**ARTICLE III: Specific Purpose**
