ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
PALM MERGER SUB, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, Palm Merger Sub, Inc., a Florida corporation (the "Corporation"), document number P12000089066, that filed its Articles of Incorporation with the Florida Department of State on October 22, 2012, hereby adopts the following amendment to its Articles of Incorporation:

FIRST: Article II of the Corporation's Articles of Incorporation is hereby amended by deleting it in its entirety and inserting a new Article II in its place to read as follows:

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

SECOND: These Articles of Amendment were adopted by the Action of the Board of Directors of the Corporation Taken Without a Meeting by Unanimous Written Consent dated as of October 29, 2012 and by the Action by Written Consent of the Sole Shareholder of the Corporation dated as of October 29, 2012. The number of votes cast for the adoption of these Articles of Amendment by the sole shareholder was sufficient for approval.
