#### ARTICLES OF INCORPORATION

#### OF

#### CARIBBEAN STANDARD GLASS MANUFACTURING, INC.

THE UNDERSIGNED, acting as sole incorporator under Chapter 607 of the Florida Business Corporation Act (the "Act"), hereby adopts the following Articles of Incorporation (the "Articles") for CARIBBEAN STANDARD GLASS MANUFACTURING, INC., a Florida corporation (the "Corporation"):

## ARTICLE I

The name of the Corporation is "Caribbean Standard Glass Manufacturing, Inc." The name of the Corporation may be changed from time to time by a duly adopted amendment to these Articles.

### ARTICLE II PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Act.

### ARTICLE VII BOARD OF DIRECTORS; OFFICERS

- A. The business and affairs of the Corporation shall be managed by or under the direction of a Board of Directors (the "Board"). In addition to the powers and authority conferred upon it by statute or by these Articles or by the Bylaws, but subject to any restrictions contained in the Bylaws or any applicable shareholders' agreement, the Board is hereby empowered to exercise all such powers and do all such acts and things as may be exercised by or done by the Corporation. In addition, the Board may elect such officers of the Corporation as the Board may from time to time determine (collectively, the "Officers"). Such Officers shall have the power and authority delegated to them by the Board.
- B. The number of directors constituting the initial Board of the Corporation is one (1). Additional directors may be elected at the initial meeting of shareholders of the Corporation in accordance with the Bylaws. The number of directors may be increased or decreased from time to time pursuant to the Bylaws, but in no event shall the number of directors be less than one (1). Unless otherwise provided in the Bylaws, election of directors need not be by written ballot.
