

CERTIFICATE OF INCORPORATION OF MR. T'S SERVICE ENTERPRISE INC.

For the purpose of forming a corporation for profit under the general incorporation Laws of the State of Florida, it is respectfully requested of the Secretary of State the approval Of such incorporation under the following Articles.

ARTICLE I

The name of this corporation shall be **Mr. T's Service Enterprise Inc.** and its principal place of business shall be at 1884 NW 64th Street, Miami, FL 33147 with the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida, as the Board of Directors may from time to time deem proper.

ARTICLE II

The general purpose and nature of the business of this corporation is to engage in any Activity or business with any or all powers for any or all purposes determined convenient or necessary by the Board of Directors as permitted under the laws of the United States and the State of Florida except as may be restricted under these Articles and it's By-laws.

If a quorum is present, the affirmative vote of fifty-one percent (51%) of the share presented at the meeting and entitled to vote on the subject matter shall be act of the shareholder.

RIGHT OF SHAREHOLDER TO DISSENT


