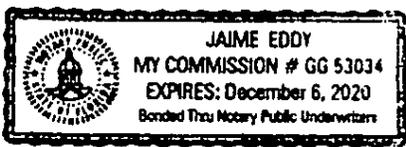

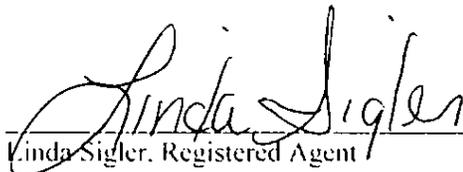

The Chairman indicated that it will be in the best interest of the Corporation the Articles of Incorporation be changed as follows:

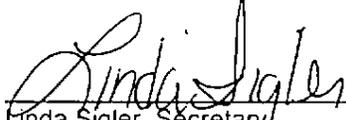
