ARTICLES OF INCORPORATION

OF

PRICELESS PRACTICES, INC.

I.

The name of the corporation is "PRICELESS PRACTICES, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

III.

The corporations shall have perpetual duration.

IV.

The corporation is a corporation for profit organized for the following purposes.

- (a) To provide marketing consultation and information to chiropractic clients;
- (b) To engage in any lawful business or activity related thereto; and
- (c) To engage in any other lawful business or activity for which corporations may be organized under the Florida Business Corporation Act.




