ARTICLES OF INCORPORATION

OF

AFFORDABLE MANAGEMENT & CONSULTING - WEST, INC.

I.

The name of the corporation is "AFFORDABLE MANAGEMENT & CONSULTING - WEST, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

The corporations shall have perpetual duration.

The corporation is a corporation for profit organized for the following purposes.




