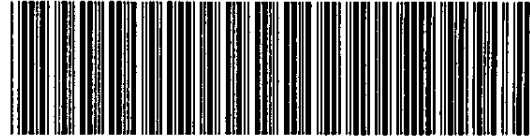

ARTICLES OF INCORPORATION

OF

I.

The name of the corporation is "AFFORDABLE MANAGEMENT & CONSULTING - MIDWEST, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

III.

The corporations shall have perpetual duration.

IV.

The corporation is a corporation for profit organized for the following purposes.

- (a) To provide marketing consultation and information to chiropractic clients;
- (b) To engage in any lawful business or activity related thereto; and

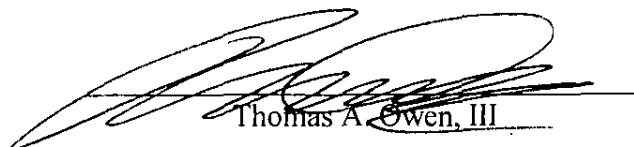

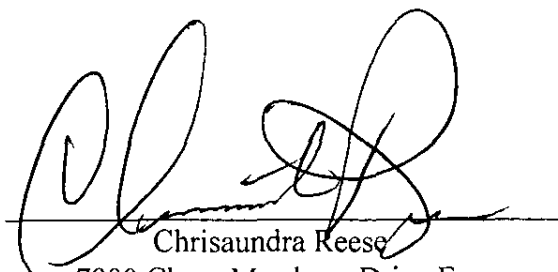
