ARTICLES OF INCORPORATION

OF

AFFORDABLE MANAGEMENT & CONSULTING - NORTHEAST, INC.

I.

The name of the corporation is "AFFORDABLE MANAGEMENT & CONSULTING - NORTHEAST, INC."

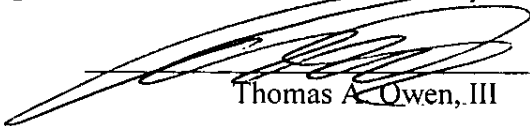

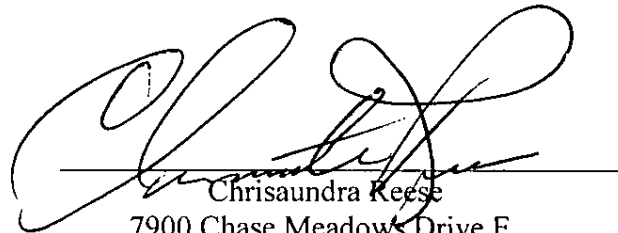
