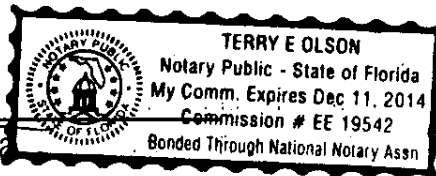
1. Introduction. Charles Buroker, being duly sworn, deposes and says:
